

Notes on Data Protection

OLBRICH is pleased about your visit on our homepage and your interest in our company.

OLBRICH takes the protection of personal data very seriously. That is why we wish to inform you which data and information we store and how we use them. The data is processed in accordance with the legal requirements of the country where the party responsible for the data processing has its registered office.

Collection of Data

During the visit of our homepage data is stored automatically. The web servers used standardly store the following:

- date and time
- the name of your internet service provider
- the web site from where you visit us
- our websites you visit
- your IP address (where appropriate, in anonymized form)
- the operating system used
- the browser you use

The data will not be utilized in a personally identifiable form, even if it might permit an identification. If we analyze the data, this will be done in an anonymized form with the purpose of improving the attractiveness, the contents and the functionalities of our homepage. In cases when data is forwarded to external service providers (web hosters), we have taken technical and organization measures to ensure that the regulations of the data protection are complied with. The processing of the data takes place in accordance with Art. 6, paragraph 1 lit. (f) DSGVO on the basis of our legitimate interests in the improvement of our website as well as the safety, functionality and stability of our homepage. A passing-on or other utilization does not take place. If there are any specific indications for an illegal use of our internet presentation, we reserve the right to verify the server logfiles subsequently.

Collection and Processing of Personal Data

Personal data will only be collected if you provide them to us voluntarily, e.g., within the scope of a registration, by filling-in a contact form, by sending e-mails, e.g., for an initiation or execution of a contract. Which data is collected can be gathered from the respective contact form. When you log in as user of the data exchange portal of our website, the user ID required for the login will be stored in addition. The processing of the data takes place in accordance with Art. 6, paragraph 1 lit. (b) DSGVO for the initiation or execution of a contract or in our legitimate interest in accordance with Art. 6, paragraph 1 lit. (f) DSGVO for answering your request.

The sending of newsletters or other information material will only take place, if you have given your consent in accordance with Art. 6, paragraph 1 lit. (a) DSGVO or if it concerns information on topics in which, within an existing business relationship, a legitimate interest exists in accordance with Art. 6, paragraph 1 lit. (f) DSGVO. You can revoke your consent at any time with effect for the future (art. 7, paragraph 3 DSGVO).

Use and Disclosure of Personal Data for Specific Purposes only

The data and its contents remain within our company, companies connected to us and with our provider. Your personal data will only be used for the purpose of which you provided them to us. Furthermore no personal data will be transferred to third parties. A disclosure to governmental institutions, authorities or third parties will only take place within the framework of national and European laws and regulations. Our employees are sworn to secrecy and to the protection of personal data given to us.

Rights of Persons Concerned

In accordance with the DSGVO you have comprehensive rights concerning the processing of your personal data. On request OLBRICH will inform you in writing whether and which personal data about you is stored in our company. An e-mail with your complete contact data to the e-mail address mentioned in the OLBRICH imprint or to the data protection officer (contact data see below) is sufficient. If in spite of our efforts to ensure data accuracy and up-to-dateness wrong information is stored, we will correct it after a corresponding note in writing. You are entitled:

- in accordance with Art. 15 DSGVO - to claim information about your personal data processed by us. In particular you can claim information on the processing purposes, the category of the personal data, the category of recipients to whom your data has been or will be disclosed, the planned duration of storage, the origin of your data, if it was not collected at our company as well as on the existence of an automated decision- making including profiling and maybe meaningful information concerning their details
- in accordance with Art. 16 DSGVO – to claim for an immediate correction of incorrect or completion of your personal data stored at our company
- in accordance with Art. 17 DSGVO – to claim for the deletion of your personal data stored at our company. A deletion of your personal data will not be possible, if we, due to national or European laws or regulations are obliged to save it.
- in accordance with Art. 18 DSGVO – to claim for the limitation of the processing of your personal data, as far as the correctness of the data is being contested by you, the processing is illegal, but the deletion of it is refused by you and we do not need the data anymore, but you will still require it for the assertion, exercise or defense of legal rights or because you have filed, in accordance with Art. 21 DSGVO, an objection against the processing.
- in accordance with Art. 20 DSGVO – to receive your personal data provided to us in a structured, conventional, machine-readable format or to claim for the transfer to another responsible party.
- in accordance with Art. 7 paragraph 3 DSGVO – to revoke your consent once given to us. This will result in us not being allowed to continue the data processing which was based on this consent in the future and

- in accordance with Art. 77 DSGVO – to complain a supervisor authority. As a rule you can address to a supervisor authority at your usual residence or workplace or at our law office.

Right of Objection

If your personal data is processed on the basis of legitimate interests in accordance with Art. 6, paragraph 1 lit. (f) DSGVO you are entitled – in accordance with Art. 21 DSGVO - to enter an objection to the processing of your personal data when there are reasons resulting from a particular situation or the objection is directed against direct advertising. In the latter case you have a general right of objection which will be implemented by us without the indication of a particular situation.

Data Retention

We store personal data as long as it is necessary for dealing with your request or performing a service you requested or to which you have given your consent, provided that no other legal obligations exist, e.g. in connection with pending litigation.

SSL and/or TLS Encryption

For safety reasons and for protecting the transfer of confidential contents such as requests which you send to us as website operator, this site uses an encryption. You can recognize an encrypted connection by the lock symbol and by the string "https://" in the browser line. When the encryption is activated, the data traffic cannot be read by third parties.

Use of Cookies

We use cookies on our homepage. These are small text files which allow the storage of specific information related to the user on the user's terminal device while the user uses the website. Cookies enable us in particular to determine the frequency of visits and the number of users of our website, to analyze the website activity behavior, but also to make our services more customer-friendly. Cookies remain stored beyond the end of the browser session and can be recalled when you visit the website again. Most browsers accept cookies automatically. If you do not want this, you will be able to adjust your internet browser in such a way that no cookies are stored on your computer or a note appears always before a cookie is created. The complete deactivation of cookies may in case of doubt result in not being able to use all functions of our website.

Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. (“Google“). Google Analytics uses so-called “cookies“, text files which are stored on your computer allowing on the one hand the recognition and on the other hand an analysis of your use of the website. The information generated by the cookie about your use of the website is normally transferred to a Google server in the USA and stored there. In case of an activation of the IP anonymization on this website, your IP address will, however, be shortened before within the member states of the European Union or in other signatory states of the Agreement of the European Economy Area. On behalf of the operator of this website, Google uses this information to analyze your use of the website, to compile reports about the website activities and to provide further services connected with the website and internet use for the website operator. Matomo

We use the Matomo Open Source Software for analyzing and statistically evaluate the use of our homepage. The information generated by cookies about the use of our website is transferred to our server. The data is summarized in pseudonymous user profiles and analyzed, in order to allow a needs-based design of our website, the user dates being anonymized by a so-called IP masking, so that a comparison of the IP address with other user data is not possible in any case. Your visiting our website is collected by the Matomo web analysis. If you do not want this, you will be able to block the storage and analysis at <https://matomo.org/docs/privacy/> .

Google Maps

On our website we use Google Maps (API) by Google LLC., 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA (“Google“). Google Maps is a web service for the

representation of interactive maps for displaying geographical information. Via the use of this service our location is displayed making it easier to possibly get to us.

Already when accessing those sub-sites in which the map of Google Maps is integrated, information on your website use (such as, e.g., your IP address) is transferred to the Google server in the USA and stored there. This takes place independent of the fact whether Google provides a user account via which you are logged in or whether a user account does not exist. In case you are logged in at Google, your data is assigned directly to your account. If you do not want the assignment with your profile at Google, you will have to log out before activation of the button. Google stores your data (even for users not logged-in) possibly as user profiles and analyzes them. The collection, storage and analysis are effected in accordance with Art. 6, paragraph 1 lit.(f) DSGVO based on Google's legitimate interests in the display of personalized advertising, market research and/or the need-based design of Google websites. You have a right of objection to the creation of these user profiles, for the exercise of which you have to contact Google.

Google LLC with its registered office in the USA is certified for the US-European "Privacy Shield" data protection agreement which ensures the observation of the data protection level applicable in the EU.

In case you do not agree with the future transfer of your data to Google in connection with the use of Google Maps, it is also possible to deactivate the web service by Google Maps completely by switching off the JavaScript application in your browser. Google Maps and thus the map display on this internet site as well cannot be used then.
